

Terms and Conditions "Lecture Capture" Competition

3. Only universities based in the UK, European Union, Norway, Switzerland and Liechtenstein are eligible to participate. Universities not eligible are participants using already Panopto TRIAL or Live System as well as employees of Panasonic and their relatives Employees of Panasonic and their relatives are not eligible to participate.
4. The participation is free of charge.
5. With his free registration the participant confirms that he has read and accepted these conditions of participation.
6. Only one registration per university is possible. The participant confirms with registration that he/she is authorized to act on behalf of the university The equipment is considered to become the property of the winning university and not the applicant himself.
